8. Overview

Currency and exchange

The official currency of the country is the Chilean peso and is represented by the \$ sign. The exchange rate varies continuously. As of June 2023, one US dollar amounts to \$790.- Chilean pesos and one euro € amounts to \$850.- Chilean pesos.

Changes can be made at the airport, exchange offices or banks. In Chile, credit cards are accepted in commercial establishments such as shops, hotels, restaurants, and travel agencies. However, it is recommended to have some cash in the national currency on hand for minor expenses.



Hours of operation

The hours of the banks are from 9:00 a.m. to 2:00 p.m. The shopping centers are open from Monday to Sunday, from 10:00 to 21:00. Supermarkets are open from 8:00 a.m. to 9:00 p.m.

Electricity

In Chile, electric currents have a voltage of 220V and 50 hertz. Devices designed for 110V will burn out when plugged in unless a voltage converter is used. It is recommended to carry voltage converters and adapters on the trip. The electrical plugs have round pins and are Italian type C or L.

Local law

The Republic of Chile is a unitary state, therefore, all laws in force are valid throughout the country. Anyone on Chilean soil must obey national laws. Claims of ignorance or ignorance will not represent any exception.

Driving vehicles

A valid driver's license (Class B or equivalent) is required to drive light motor vehicles. This type of license authorizes the driving of vehicles with three or more wheels and up to nine seats, plus the driver's seat.

Foreigners entering the country on a tourist visa may drive vehicles as long as their visa is valid, provided they carry a legally valid driver's license from their home country, and that the driver's license is equivalent to a non-professional Chilean Class B driver's license.

Alcohol

The legal drinking age is 18. Alcohol consumption is only allowed in private and indoor areas. The sale and promotion of alcoholic beverages is not allowed in sports facilities. Alcohol tasting events can only be held indoors, where minors are prohibited from accessing.

Tobacco

Only people over the age of 18 can use tobacco or tobacco products. Tobacco use is only allowed in private areas and in public and open spaces. In general, sports facilities are smoke-free zones, and smoking is only allowed in those facilities that have specific designated areas for smokers.

Guidelines in case of earthquake

Chile is prone to earthquakes. In the Metropolitan Region, where Santiago is located, most of the constructions are modern and designed to withstand any seismic movement, which provides additional security to the inhabitants and visitors.

While the earthquake is still happening: If you are inside a house or building, you should stay indoors, unless the construction is visibly deteriorated. If you are outdoors when the movement begins, stay away from buildings, trees, streetlamps, and overhead wires. It should remain outdoors until the earthquake is over. If you are in a vehicle, it is suggested to turn off the engine and stay inside the vehicle. Once the shaking is over, act carefully. Avoid bridges or ramps that could have been damaged during the earthquake. Always follow the emergency instructions of the place where you are.

After the earthquake: Avoid walking barefoot, as there may be glass and other sharp objects on the floor. You should be prepared for aftershocks, which can occur several months after the main earthquake.

Street sexual harassment

In Chile, street sexual harassment is a fault that offends people's morals and good manners, Chilean law qualifies it as a crime and punishes those who are declarators Guilty. In addition, the National Karate Sports Federation of Chile has a protocol against abuse, harassment and discrimination in sport that could be applied in this event.

9. Visa requirements

Visas and Immigration

All foreigners must have a valid passport or travel document to enter Chile. If necessary, the traveler must also have a valid visa.

Agricultural and Livestock Service (SAG)

To prevent exotic diseases, quarantine infestations and/or economically dangerous species in accordance with Chile's foreign agricultural policy, the Agricultural Service (Servicio Agrícola Ganadero - SAG) establishes strong regulations for products of plant and/or animal origin entering the country.

The recommendation of the SAG is always to make the declaration, when you have doubts about the products you are bringing to Chile. If you have any questions about the product declaration declaration, please do not hesitate to ask a SAG officer at the airport, who will help you complete the document.

Customs legislation

If you travel to Chile with personal belongings such as: film equipment, film camera, skins or similar, you must fill out a temporary import application form and send it to the International Police (PDI). Otherwise, you must pay the customs tax.

The Customs Office conducts random checks on traveler's luggage at the airport. If you are selected for this inspection and are in possession of goods that you did not declare, the customs authorities will decide whether you should pay a custom fine, be deprived of your goods, or even be charged with a penalty violation leading to jail time.

10. City/country information

Chile is located at the southwestern tip of South America, between the Andes Mountains and the Pacific Ocean. Its surface extends over 4,200 kilometers, which allows you to find diverse landscapes and climates throughout its territory. In the extreme north we find the Atacama Desert, the driest desert in the world, and in Patagonia, millenary glaciers.

Santiago, capital of Chile, is in a fertile valley that has a pleasant Mediterranean climate in which the Andes are imposed with great majesty. The city, very cosmopolitan, has a wide variety of restaurants that offer a wide culinary range, an excellent infrastructure of hotels, business places and large shopping centers that meet the most demanding international standards. The city has areas dating from the colonial period, interesting museums and unparalleled facilities that connect the visitor with nature. Ski centers of international level, the Maipo Valley with its world-renowned vineyards and the Pacific coast with cities such as Valparaíso and Viña del Mar all of them with an unparalleled natural landscape.

Culture

Some of the newest attractions in the city are: the Sky Costanera viewpoint, the tallest tower in Latin America with its 300 meters high; the Gabriela Mistral Cultural Center (GAM), a monumental building dedicated to arts and culture; the Palacio de La Moneda Cultural Center, an underground museum with exhibitions from around the world, and the Mirador Interactive Museum (MIM), filled with artifacts that allow you to experience science.

The city also has traditional areas that showcase the old town, such as the Central Market, the Palace of Fine Arts, the Palacio de La Moneda, Cerro San Cristobal, and the Plaza de Armas, all located in the historic center of the city. Restaurants, bars, parks, concerts, parties, bookstores, museums, pubs, and first-class architectural projects give life to a modern and cosmopolitan city. In 2011, The New York Times named Santiago de Chile a must-visit place.

Geography and climate

The city is situated in a geographically distinctive location, surrounded by mountain ranges. The country itself is a long, narrow strip of land: just 116 km separate Santiago from the coastal city of Valparaíso. The nearest ski centers are 50 km from Santiago, about an hour away.



The climate has Mediterranean patterns, with 80% of rainfall during the winter. In August, the average temperature is 17°C (63°F).
